## 1. Electoral College List:

- A. Each District Boxing Association shall be represented by two elected EC members authorized by the President or Secretary General / Secretary of the duly affiliated District Boxing Association. However, in case the President / Secretary General / Secretary nominates a different person(s), the person (s) authorized by the President shall be deemed to be the duly authorized person(s).
- B. One representative shall represent each duly provisional affiliated Unit and shall not have voting rights.
- C. Each District Boxing Association and each provisional affiliated Unit have intimated the name(s) of their representative(s) by 13<sup>th</sup> February 2026. Such intimation were addressed to the Maharashtra Boxing Association on their letterhead duly signed by the President / Secretary General of that District Boxing Association. Such list was published on the website of the MBA on 13/02/2026 as well as circulated via email to all members. The format of such letter is annexed hereto as “**Annexure A**”. They were also given opportunity to raise objection against any name upto 16/02/2026 till 11: 00 am.
- D. The Returning Officer appointed by Maharashtra Boxing Association shall prepare the list of the authorized representatives of the District Boxing Associations (“Lina; Electoral College List”), after considering the Objections, and later in the prescribed “**Form 1**” annexed hereto as “**Annexure B**” and circulate a copy of the list so prepared by him to all District Boxing Associations latest by 16/02/2026 by via email as also display on the website of Maharashtra Boxing Association ([www.maharashtraboxingassociation.com](http://www.maharashtraboxingassociation.com)).
- E. This list shall be treated as the Final list of Voters, for the purpose of the Election 2026.

## 2. **Nomination of Candidates:**

- A. The nomination of a candidate for election as President or Secretary or Treasurer or Vice President or Joint Secretary or Member shall be made in prescribed “**Form 2**” annexed hereto as “**Annexure C**”.
- B. The nomination of a candidate for election as President or Secretary or Treasurer or Vice President or Joint Secretary or Member shall be proposed by one of the authorized representatives of the District Boxing Associations whose name is included in the Electoral College List in “**Form 1**” and also subscribed by 1(one) such authorized representative as seconder.
- C. Each candidate shall be entitled to be nominated by not more than 2 (two) nomination papers.
- D. Candidate shall submit his nomination paper by email to the Returning Officer by the candidate himself/herself from 17/02/2026 to 20/02/2026 between 11:00 am to 3:00 pm. Abiding by the Model Election Guidelines 2011 and for sake of convenience of long distance and limitation of time, the printed copy can be submitted to R.O. by the Authorised Representative of the Candidate as per Annexure 23.
- E. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; Please note that if he/she does so, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- F. No person shall be permitted to withdraw his / her name as proposer / seconder, once the nomination paper subscribed by him / her has been delivered to Returning Officer.

G. On 20/02/2026, the Returning Officer shall prepare a list of all nominations received by him; post wise in prescribed **Form 3** annexed hereto as “**Annexure D**”; and the list of nominations received will also be displayed on the website of Maharashtra Boxing Association ([maharashtraboxingassociation.com](http://maharashtraboxingassociation.com)).

### 3. Scrutiny of Nominations:

- A. On 21/02/2026 from 11:00 am onwards, the Returning Officer in his/her office or place prescribed by him/her shall scrutinize each nomination paper, one by one, received by him and determine its validity or otherwise.
- B. At the scrutiny of nominations, each Candidate or his / her Authorized Representatives shall have the right to be present and raise any objection concerning the nomination of a candidate for the post of which he/she has filed his / her nomination.
- C. As soon as may be after the scrutiny of all nomination papers has been completed by him/her, the Returning Officer shall prepare a list of validly nominated candidates in prescribed “**Form 4**” annexed hereto as “**Annexure E**” and circulate a copy of the list so prepared by him to all District Boxing Association by display on the website of Maharashtra Boxing Association ([maharashtraboxingassociation.com](http://maharashtraboxingassociation.com)). The contesting candidates can take a copy of a list of validly nominated candidates from the Returning Officer.
- D. R.O. shall also publish on the website, the Minutes of the Scrutiny process as well as the decisions on the Objections on Nominations, for the information of all as well as abiding the Principle of Transparency abiding the Principle of Total Disclosure.

### 4. Withdrawal of Candidatures:

- A. Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his / her candidature, by physically presenting it to R.O., by

- B. Notice of withdrawal of candidature shall be submitted in prescribed “**Form 5**” annexed hereto as “**Annexure F**”, either by the candidate himself/herself or by a person duly authorized by him / her in writing.
- C. Notice of withdrawal of candidature shall be final and shall not be allowed to be canceled.
- D. The Returning Officer shall accept the notice of withdrawal if he/she is satisfied with the notice's genuineness.
- E. On the 24/02/2026 the Returning Officer shall prepare a final list of contesting candidates in prescribed “**Form 6**” annexed hereto as “**Annexure G**”, and display a copy of the said list on the website of Maharashtra Boxing Association ([maharashtraboxingassociation.com](http://maharashtraboxingassociation.com)) and also furnish a copy of the same to each of the candidates / their authorized representatives if they demand so.

## 5. **Poll:**

- A. The **poll**, if necessary, shall be taken post-wise, on **1<sup>st</sup> March 2026** between 11:00 am to 1:00 pm and shall commence during the Annual General Meeting called for the elections, as per the schedule.
- B. The poll will be by secret ballot.
- C. Each contesting candidate can nominate one person, (if he/she desires so), to be present at the Poll (Polling Station).
- D. The voter shall record his / her vote on the ballot paper by placing a tick mark ( ✓ ) against the name of the candidate of his / her choice, and any other mark like ( X ), etc. or word, placed on the ballot paper by him/her shall render the ballot paper liable to rejection.
- E. The tick mark ( ✓ ) to indicate the vote shall be placed by the voter only using an article specifically provided for the purpose by the Returning Officer, and a ballot

paper marked otherwise using any pen, ballpoint pen, etc. by the voter shall render the ballot paper liable for rejection.

- F. The ballot paper marked by a voter shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer and placed at such a noticeable place in the polling station that it shall be constantly visible to all present in the polling station.
- G. The specimen ballot papers for the post of President or Secretary or Treasurer or Vice President or Joint Secretary or Member shall be declared after the list of contesting candidates are published.
- H. The Returning Officer shall close the poll at the appointed hour; however, all those voters who are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.
- I. After all the voters have voted, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.

## 6. **Counting of Votes:**

- A. The Returning Officer shall take up the counting of votes, post-wise and category-wise.
- B. The Returning Officer shall thereafter ascertain the result of counting, the candidates who have secured maximum number of votes in the said descending order, post-wise and category wise, where applicable, equal to no. of seats to be filled for each post or category of posts, where applicable, shall be deemed to have been duly elected to those posts.

## 7. **Declaration of Results:**

The names of contesting candidates who have been elected at the election shall be declared as having been duly elected to their respective posts, by the Returning Officer at

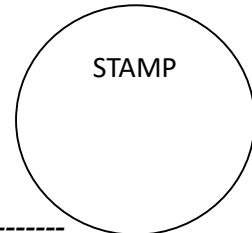
