Sir,

I most respectfully submit as below;

- A. The MBA Interim Body sought my consent for appointment as RO for March 2026 Election. I have worked as Deputy Election Commissioner in State Election Maharashtra from 2011 to 2023, when I have directly been in the process of conduct Constitutional Elections to more than 90,000 local bodies. I have also been part of conduct of election to sports bodies like Mumbai Cricket Association, Maharashtra Cricket Association etc.
- B. After perusing the object, statement and reason of The National Sports Governance Act 2025, and more specifically Chapter VIII Section 16(6), and also after perusing the Constitution of Boxing Federation of India (hereinafter referred as **BFI**) and the MOA , AOA and election provisions of Maharashtra Boxing Association (hereinafter referred as **MBA**)and knowing that the National Body has not formed any Election Panel for conduct of elections of its affiliates and specifically knowing that BFI has concurred to my appointment as Returning Officer (hereinafter referred as R.O.); I have accepted the responsibility as an R.O.
- C. Accordingly, the **MBA** Interim Body has appointed me as R.O. vide their letter and email dated 12/02/2026, which is duly received by me on 13/02/2026.

D. At the outset it is made clear that, the election conduct shall be as per the existing Constitution of MBA, relevant Acts, relevant rules, various directions of Apex Body and the Model Election Guidelines issued under the Act.

F. The MBA shall request the BFI, to appoint an Observer for the elections.
